Pursuant to art. 13 of the EU Regulation n. 2016/679 (GDPR), laying down provisions for the protection of persons and other subjects regarding the processing of personal data, we wish to inform you that the personal data you provide will be processed by Prima srl in compliance with the aforementioned law and the confidentiality obligations.

## 2. Purposes of the Treatment

The data you provide will be used for the sole purpose of implementing the relationship between the parts that we generally define "contract", below the details of the purposes:

- a) execution of the contract;
- b) fulfillment of obligations established by laws related to the contractual relationship;
- c) management of the contract, possible external professional collaborations for the fulfillment of legal obligations;
- e) protection of contractual rights;

The contract constitutes the legal basis of the processing.

## 3. Processing methods

Personal data will be processed in paper form, computerized and telematic and included in the relevant databases that will be accessible by the persons in charge of data processing.

The processing may also be carried out by third parties who provide specific processing, administrative or instrumental services necessary to achieve the aforementioned purposes.

Please note that, in compliance with the principles of lawfulness, purpose limitation, integrity, confidentiality, availability and data minimization, your personal data will be kept for a time period necessary to achieve the purposes for which they are collected and processed.

## 4. Communication and propagation of data

We also inform you that the collected data will never be disclosed and will not be communicated, except for the necessary communications that may involve the transfer of data to public bodies, consultants or other subjects for the fulfillment of legal obligations.

## 5. Transfer of personal data

## 6. Existence of an automated decision-making process, including profiling

Prima srl does not adopt any automated decision making process, including profiling, referred to in Article 22, paragraphs 1 and 4, of EU Regulation no. 679/2016.

## 7. Rights of the interested party

At any time, you may exercise, pursuant to articles 15 to 22 of EU Regulation no. 2016/679, the right to:

- a) request confirmation of the existence or otherwise of personal data;
- b) obtain information on the purposes of the processing, the categories of personal data, recipients or categories of recipients to whom the personal data have been or will be communicated and, where possible, the retention period;
- c) obtain the correction and deletion of data;
- d) obtain the treatment limitation;
- e) obtain data portability, ie receive them from a data controller, in a structured format, commonly used and readable by automatic device, and transmit them to another data controller without hindrance;
- f) oppose the processing at any time and also in the case of treatment for direct marketing purposes;
- g) to oppose an automated decision-making process regarding people, including profiling.
- h) ask the data controller to access personal data and to rectify or cancel them or limit their processing or to oppose their processing, in addition to the right to data portability;
- i) withdraw the consent at any time without prejudice to the lawfulness of the treatment based on the consent given prior to the revocation;
- j) to propose a complaint to a supervisory authority.
